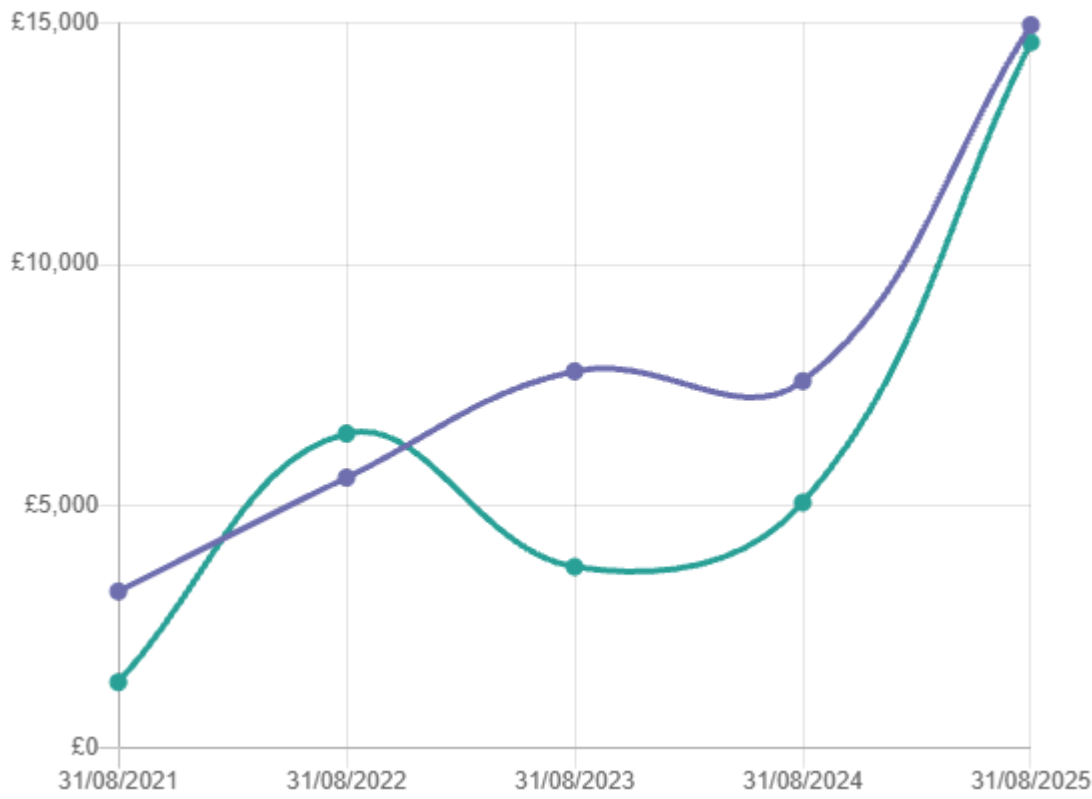
Trustees
